This memorandum requests your cooperation in completing a questionnaire on local road safety funding and resources. The purpose of this questionnaire is to better understand the extent to which Federal and state funds and other resources are being used for local road safety improvement projects. .

We are examining state Department of Transportation (DOT) practices for delivering or applying safety funding resources to local agencies for road safety improvement projects and identifying noteworthy practices that may be implemented in other states. The information will be used to identify noteworthy practices used to develop and implement safety projects and challenges and barriers state and local agencies encounter during the process. Individual questionnaire responses will not be shared publicly.

The questionnaire is divided into four sections. The first section provides background information on the questionnaire respondents and their roles and responsibilities. While this survey is primarily directed at state DOTs, we encourage respondents to reach out to contacts in or representing local agencies to assist with answering some of the questions. This might include representatives from the State local technical assistance program (LTAP), regional planning organizations or local public agencies themselves. Section two collects information on the extent to which states are distributing funds to local agencies for safety projects and the human resources and technical assistance available to local agencies to identify, develop and implement local safety projects. This information will be used to assess the current state of practice. Section three inquires about specific noteworthy practices states are using to improve local road safety. Section four assesses challenges and barriers faced when developing and implementing local road safety projects.
